TERMS and CONDITIONS

GENERAL

The Smiles Plus Dental Membership Program is governed by the following terms and conditions. All individuals purchasing memberships with Sanilac Smiles Dental Care are expected to understand these terms and conditions. Members are required to accept these terms and conditions before receiving its benefits. Sanilac Smiles Dental Care reserves the right to make changes to these terms and conditions at any time

MEMBERSHIP POLICIES

Membership Fees must be paid in-full before membership can be established.

Memberships include coverage for the purchasing member only. Membership privileges do not extend to family members. Photo identification will be required, if requested, when visiting, in order to verify the identity of a person possessing a Smiles Plus Dental Membership.

Sanilac Smiles Dental Care has the right to cancel memberships before the duration stipulated if they deem there has been unauthorized use of the membership and NO refund will be given.

You must be at least 18 years old to purchase a Smiles Plus Membership. Parents can purchase a Smiles Plus membership on behalf of their dependent children who are under 18 years old. Anyone 18 years and older may purchase a Smiles Plus Membership as a gift for another person.

Sanilac Smiles Dental Care does not suspend or "freeze" memberships. Memberships are non-refundable and begin on the date of payment and end on the day the one year anniversary is reached.

The member agrees and understands that they are entering into a binding contract by accepting the Terms and Conditions.

Membership fees may be adjusted at annual renewal

Membership benefits are not transferable, have no cash value and may not be redeemed for cash.

Treatment fees will be calculated based on the current usual and customary fees at the date of service. Usual and customary treatment fees can change at any time.

An examination must be completed in combination with each prophylaxis appointment and with at least 2 of every periodontal maintenance appointments per year

Membership must be current to receive membership plan benefits and discounts.

Sanilac Smiles Dental Care retains the right to interpret and implement any membership program details, stipulations, and benefits at its sole discretion.

All benefits available to current members must be used within the one year enrollment period and cannot be carried over to another enrollment period.

This membership program is exclusive to Sanilac Smiles Dental Care and cannot be used at any other dental office or dental specialist office.

This membership plan is non-refundable. No refunds will be given if a member chooses not to use their plan benefits or fail to schedule an appointment for timely treatment, including situations in which an available appointment cannot be found to accommodate the member's personal schedule.

Sanilac Smiles Dental Care reserves the right to cancel your membership without prior notice at any time and for any reason. In the event Sanilac Smiles Dental Care cancels your membership for any reason other than

non-payment of membership enrollment fees, you shall receive a pro-rated refund of the enrollment fee within 30 days of the effective date of membership cancellation as determined by Sanilac Smiles Dental Care

Sanilac Smiles Dental Care will have the right to refuse treatment or cancel any membership at the incorrect price in the event a membership fee or treatment fee is listed at an incorrect price or with incorrect information due to a typographical error in pricing or product information.

Sanilac Smiles Dental Care may, but is not required to, give notice via mail, email, telephone or any other method of communication that your membership will be expiring, prior to the membership expiration date of the one year membership term.

It is the responsibility of the members to supply Sanilac Smiles Dental Care with current payment information to process a membership renewal without a lapse in membership.
